



## **AFL/NRL Grand Final Competition 2010 – Terms and Conditions**

1. Information on how to enter and prizes form part of these conditions of entry. By entering the promotion, entrants accept these Conditions of Entry.
2. The promotion is known as the “AUSTAR AFL/NRL Grand Final Competition 2010”.
3. The promotion commences at 12.01am (AEST) Monday August 30, 2010 and closes 23.59pm (AEST) on Monday September 13, 2010 (“Promotional Period”).
4. Entry is only open to current AUSTAR residential customers who receive the AUSTAR service during the promotional period.
